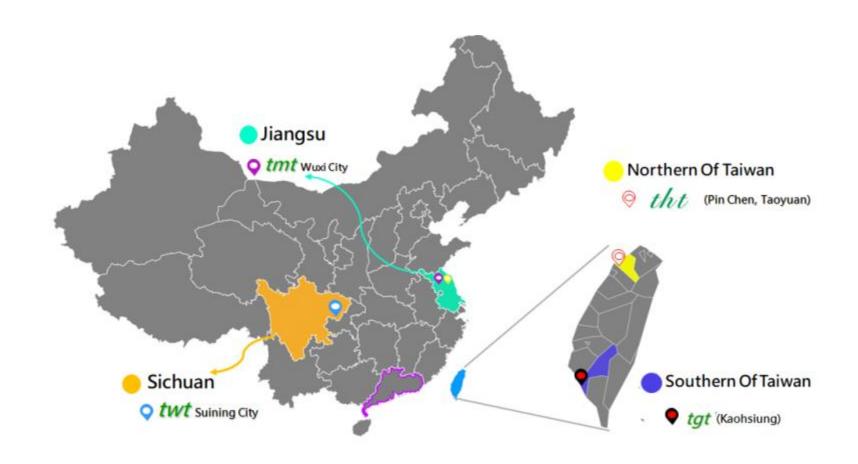

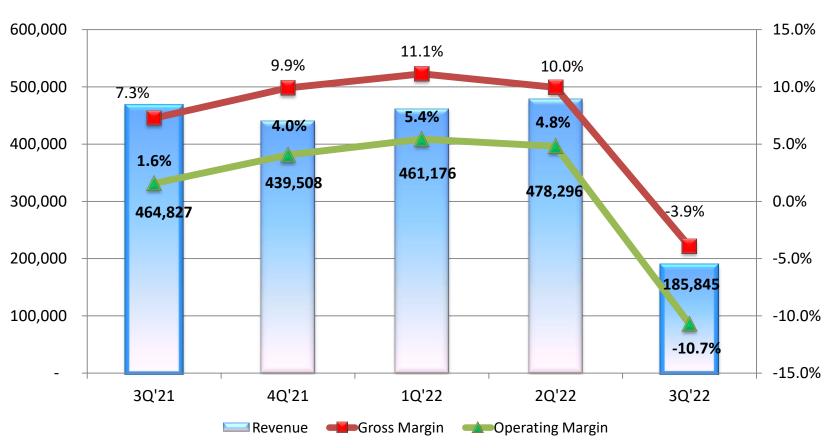

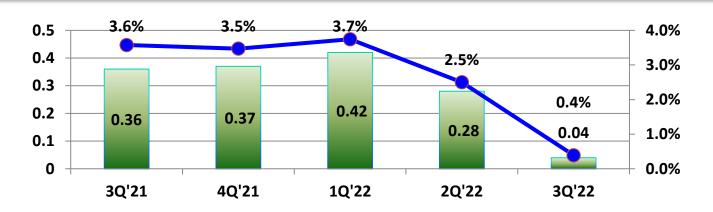
Consolidated Sales & Profit Trend(Quarterly)

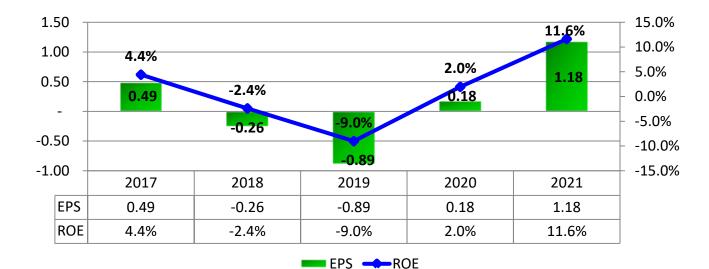
